ARE THEY AS ENTHUSIASTIC AS YOU ARE?



cerns about Colorado's expanding soils and mold issues. Ask questions such as: Do they provide geological engineering and testing? Do they construct homes with a floating floor system? Do they have venting between floors to protect against moisture and mold? Does their stucco application protect against moisture? How is the subfloor constructed? Are they familiar with water recirculation systems and in-floor heating?

The answers to these questions will help a person decide if they're making the best choice for their dream home.

ARE THEY COVERED?

While it's not nearly as much fun to think about as plans for the master bedroom, customers need to know what kind of insurance policies different builders carry. Be sure that a custom home builder has all of the liability and workers' compensation insurance necessary to cover any accidents on the job site.

If they don't have the proper insurance, you could lose your lot and potentially be liable for any injuries that occur on the job site.

It doesn't seem fair, but without checking for this important information, a person's dream home could become a lawsuit.

The best way to handle this is by requesting the builder's insurance records and having them examined by your own insurance professional.

In any custom home building process, there must be a tremendous amount of trust. You and your builder will be going on this journey together, and no matter how detailed the blueprints may be, unexpected issues do come up with one-of-a-kind homes.
